Odisha State Open University (OSOU) invites response to EOI from reputed Software Vendors /Authorized Partners (hereinafter referred to as 'vendors') who can provide a readymade Learning Management System (LMS) to provide training to the students of the University. The LMS software offered may have to be customized to meet OSOU's specific requirements.

The vendors are requested to submit the response to EOI, all the required documents, and a copy of the EOI document for having noted the contents and testifying conformance to the terms and conditions set out therein. All the pages should have a company seal and signature.

The response to EOI is required to be in a sealed cover superscripted as 'Proposal for Learning Management System' as per the formats prescribed and submitted on or before the last date of submission indicated herein below. If the bid is sent through post / courier, the vendor should ensure that the Bid documents are received at OSOU Headquarters before the scheduled date and time.

The authority at its discretion may issue the RFP to the short-listed vendors from EOI responses or go in for an open RFP at the time of procurement. OSOU's decision in this regard will be final.
