- 8. The firm shall submit latest audited balance sheet for last three years.
- 9. In case of any dispute between parties regarding the interpretation of the terms and conditions, Hon'ble Vice-Chancellor, Odisha State Open University will be the sole arbitrator, who will adjudicate the matter under arbitration laws and whose decision shall be final and binding upon both the parties.
- 10. Performance Security of 5% (Refundable) on the basic price of the goods to be deposited by the firm in shape of Bank draft from a scheduled bank within 15 days of placement of supply order or shall be deducted from the total amount of the invoice which shall be valid up to one year. The security deposit amount will be forfeited if the work is found to be unsatisfactory during the period. The Security Deposit amount shall be refunded without any interest.
- 11. If supply is not made within the stipulated period and the time is not extended, the supplier will be liable to pay compensation equal to one percent or such percentage of the total amount of contract as the appropriate authority may decide for every day that the quantity remains incomplete provided that the entire amount of compensation shall not exceed ten percent of the total amount of the contract. In such a situation OSOU have the power to deduct the amount of compensation from any payment due to the supplier.
- 12. The Competent Authority shall have the rights to alter, modify or delete any terms or conditions before placing any order.
- 13. Taxes as applicable (GST & TDS) shall be deducted as per the prevailing Government guidelines.
- 14. OSOU reserves its right to evaluate/shortlist/accept/reject/eliminate any firm at any stage without assigning any reasons thereof to the firm.
